

# U.S. Treasury Capital Projects Fund for Libraries

### Grant Opportunity: Department of Libraries Capital Project Fund

The State of Vermont has submitted a proposal to the U.S. Treasury to grant \$16.4 million of our state's Capital Project funds toward capital improvements to **Vermont's public libraries**. These funds are intended to address critical building improvements to ensure Vermonters have continued access to high-speed Internet to directly enable work, education, and health monitoring at their local public libraries.

## **Eligible Projects**

Projects that make public libraries more accessible to Americans with disabilities, improve ventilation and filtration of air, or address structural issues that threaten the integrity of the building could all be eligible for this funding.

#### **Timeline**

The Department of Libraries will launch a competitive grant process through which Vermont communities can access both sets of federal funding to support capital improvements to their local public library.

Our goal is support communities in successfully accessing both the federal ARPA funds and Congressionally Directed Spending funds for which their public library is eligible. We aim to have one application process for both grant opportunities.

Upon finalizing the grant application materials and process, the Department of Libraries will share the application process and timeline via a webinar for public library staff and trustees.

We anticipate collecting Needs Assessments from libraries with capital project needs in February 2023, followed by an application process in Spring 2023.

We anticipate grant awards may be made as early as spring 2023 so that projects can begin as early as summer 2023.

Building projects must be completed by December 31, 2026.

**Note:** The U.S. Treasury Capital Projects Fund for Libraries grant funding is separate from the \$10 million in Congressionally Directed Spending (CDS) for Public Facilities Preservation Initiative Grants which provide resources to address repair and mitigation needs in small, rural public libraries that also serve as community meeting spaces and public facilities, with a focus on economically depressed areas. The Department of Libraries will issue one grant application for both grant opportunities.
