

## TERMS OF AGREEMENT OneClick Digital from Recorded Books Downloadable Audio and eBook Subscription

The purpose of this program is to make the Recorded Books OneClick Digital Library (OCD) program available to subscribing Vermont public libraries, at a volume discount.

VTLIB's Contract with Recorded Books is dependent on a sufficient number of library subscriptions to cover 100% of the \$25,000 cost for a year of service, **April 1, 2015 to March 31, 2016.** VTLIB will act as the contract manager and fiscal agent for this project on behalf of all participating libraries. All Vermont public libraries are eligible to join the VTLIB/OCD subscription program during this open enrollment period.

The cost to individual subscribing libraries for 2015-2016 is based upon total library circulation, and is assessed according to the FY2013 circulation figures reported to VTLIB (See pricing schedule below). The price for individual libraries provides access to the audiobook and eBook platforms and gives the consortium additional money to spend on content (audio, eBooks, or both). The Collection Development Committee is responsible for purchasing content throughout the year. eBook prices range from \$1.99 to \$90.00 so the size of the collection will vary based on titles purchased.

The library may choose to be a part of this consortium plan AND also have an individual library "advantage" plan with Recorded Books. This is a great way for a library to add eBooks or audiobooks exclusively for its patrons. These purchases would be made with additional funds from the library's own budget. Subscribing libraries are authorized to offer the OCD service of downloadable audio books and eBooks to registered library patrons holding a valid library patron barcode. Participating libraries must register these patron barcodes with VTLIB before OCD service begins.

Libraries participating in OCD will take actions they deem reasonable to limit unauthorized access to the licensed content. *The OneClick Digital Library license is for this library only.*
