During this season of giving thanks and looking forward to the New Year, I would like to update the Vermont library community on the many changes happening at VTLIB. We are in an exciting time of rebuilding and planning for the future, and I am eager to share this update with you.

As you may know, VTLIB has gone through systemic changes over the past few years, including funding cuts, staff departures, and a strategic restructuring-all while working to keep VTLIB vital and relevant.

This year, VTLIB hired several new staff members, and I've been working with them to develop a new vision and service philosophy. We face competing priorities, and the limitations imposed by our reduced funding and staffing demand a fresh take on our programs. Our shared vision is to provide leadership for library services in Vermont, help libraries of all types in VT better serve their communities, and meet the goals of our funders. This is part of our mission to realize the Governor's priorities of growing the Vermont economy, making Vermont a more affordable place to live, and protecting vulnerable populations.

Congratulations libraries of Vermont! Clover has officially passed the 20,000 interlibrary loan requests made mark! Since the launch of Clover on August 1st of this year, libraries around the state have been linking in their catalogs, lending, borrowing, and learning all about this new system. Here are a couple of statistics for the end of the year:

- Number of requests (at time of article submission): 20812
- Number of catalogs linked: 115

Do cookbooks fly off the shelves at your library? Are patrons interested in the localvore movement? Are you a secret foodie yourself? If so, be sure to check out the *Culinary Arts Collection*.

You can look up the stevia leaf to find recent, accurate research on this new sweetener (a wild herb from South America). A search for "localvore" brings up an article about the Brattleboro Food Coop. Do you know what jicama is or what it's used for? A keyword search reveals articles about prebiotics and use of jicama by restaurants in creative slaws.

With a quick search in the *Culinary Arts Collection* database, you can show your patrons yet another way their library provides more than they might expect!

Surprise your patrons by telling them about the *Culinary Arts Collection* - available for free from your library through Vermont Online Library!

(con't.) A Note from the State Librarian

First, the vision, as articulated in our Library
Services and Technology Act (LSTA) Five-Year
Plan: The Vermont Department of Libraries will
support Vermont libraries' ability to become hubs of
lifelong learning, offering free, universal, and
convenient access that will improve quality of life
and strengthen our communities. Our services will
help grow the Vermont economy, reinforce and
support various approaches to literacy, and make
library services more accessible to vulnerable and
underserved populations.

VTLIB works to meet the goals we set with our federal funders (through the LSTA plan), the goals we set with the Governor and Legislature (our state funders), and the needs expressed by all types of libraries in Vermont (public, school, academic, and special) and the patrons of those libraries. This wide

range of goals requires us to juggle competing priorities while also working to help our funders understand the important work we and all of you do for every citizen in Vermont.

Second, I would like to talk about the people who make this happen: the VTLIB staff. We have recently welcomed Jason Broughton aboard as Assistant State Librarian for Library Advancement. Jason leads our Library Advancement Division.

Jason's Library Advancement colleagues are also all new in 2017: Lara Keenan is Library Consultant for Governance and Management, Vin Livoti is Library Consultant for Special Populations and head of the Special Services Unit, and Cass Mabbott is Youth Services Consultant. Jason, Lara, Vin, and Cass are your subject specialists for consulting.

Our Professional Development and Small Library Consultant position is currently vacant: This position will revitalize the Continuing Education program for all types of libraries in Vermont and coordinate its implementation. This person will also provide additional consultation services to libraries in partnership with Lara, Vin, and Cass.

In our Information and Access Division, Tom McMurdo is Assistant State Librarian for Information and Access. Tom acts as leader and coordinator for the Information and Access consultants and support staff.

April Shaw is Head of Interlibrary Loan and Government Services Librarian. April is available to answer your questions about CLOVER and interlibrary loan.

Information Technology Consultant - Vacant: This position will act as primary consultant for VERSO (the library management system), the State Data Coordinator, as well as, a consultant on IT issues for all types of libraries in Vermont.

In addition to these consultants, VTLIB has numerous staff who support the work of the consultants and myself, manage grants, do interlibrary loan work, and much more. In many ways, they are the backbone of the organization.

Some of our current projects:

• Leverage state agency and department partnerships for better usage of state

resources:

- Securing funding for upcoming years;
- Moving VTLIB: By July 1st, 2018, all of VTLIB - including the staff, books, materials, and offices in Montpelier and Berlin - will need to be packed up and moved to our new location in the VT Historical Society building in Barre. This challenging task will take a great deal of planning between now and July;
- Statewide Courier System for interlibrary loans securing a vendor, negotiating a contract, and implementing that program for all types of libraries in Vermont;
- VERSO Transition for libraries in Vermont who are moving over to this new library management system;
- CLOVER Transition continued transition activities around the new interlibrary loan system;
- Onboarding new staff continuing to form our new team, hiring the remaining 2 vacancies, and setting priorities for the next year;
- Redesigning the Continuing Education and Library Certification program to ensure libraries have robust and relevant options for trustees and staff:
- Continued refinement of our consultation method and philosophy.

Future Projects:

- Re-evaluating State Standards for Libraries
- Emergency Preparedness for Libraries
- Modifying State Statistics for Public Libraries

I hope this update gives insight in the exciting future for VTLIB and the challenges we face as we look eagerly towards that future. I am working hard to make sure that all our funders understand how essential libraries of all shapes and sizes are to the citizens of Vermont. My focus remains on VTLIB as a strong, sustainable presence in state government so that we can continue to be here to support your essential work.
