

## Public Facilities Preservation Initiative Grants Funding for Libraries

On December 23, 2022, The U.S. House of Representatives passed the Consolidated Appropriations Act, 2023, an omnibus spending bill consisting of all 12 fiscal year 2023 appropriations bills.

The bill contains more than \$212 million in Congressionally Directed Spending (CDS) included by Sen. Leahy, for 38 projects across Vermont. The bill was approved by House and Senate and signed by President Biden.

The Vermont Department of Libraries will receive \$10M for Public Facilities Preservation Initiative Grants to pass through to the state's small, rural public libraries. This funding is administered by the U.S. Department of Housing and Urban Development (HUD) through their FY2023 Economic Initiative Community Project Funding program.

### **Grant Opportunity: Public Facilities Preservation Initiative Grants**

The goal of these funds is to provide resources to address repair and mitigation needs in small, rural public libraries that also serve as community meeting spaces and public facilities, with a focus on economically depressed areas.

### **Eligible Projects**

Small, rural public libraries in Vermont are the focus of the Public Facilities Preservation Initiative grants. Projects that are vital to the functioning of the library, including those that address ADA, HVAC, the building envelope (roof, foundation, walls, windows, etc.), and new construction will all be considered.

### **Timeline**

The Department launched a Needs Assessment form on February 28, 2023. The goal of the Needs Assessment is to gather information from municipal and incorporated public libraries in Vermont about their needs for capital improvements, what stage they are at in planning those projects, and what funding gaps they have identified. It will be open for public libraries to complete through March 31, 2023, and participation is highly encouraged for any libraries with anticipated construction needs.

The official Application for grant funds will launch following the completion of the Needs Assessment later this year. The Department of Libraries will launch one competitive grant process through which Vermont communities can access both sets of federal funding to support capital improvements to their local public library.

HUD has established August 31, 2031, as the end date of the period of performance and budget period for all FY2023 CPF grants.

**Note:** The Public Facilities Preservation Initiative grant funding is separate from the \$16.4 million in funding in U.S. Treasury Capital Project Funds for capital improvements to Vermont's public libraries. Those funds will address critical building improvements to ensure Vermonters have continued access to high-speed Internet to directly enable work, education, and health monitoring at their local public libraries and are not limited to small and rural libraries. The Department of Libraries is awaiting approval of our grant program from the U.S. Treasury, which we hope to receive this winter.
