State Statutes Relating to VTLIB

§ 605. Duties and functions of the Department of Libraries

- (1) A law library to serve the Supreme Court, the Attorney General, other members of the Judiciary, the legal profession, members of the Legislature, officials of State government, and the general public.
- (2) A collection of federal documents.
- (3) An information and reference service to State government, including a comprehensive collection of current information relating to matters of public policy and topics pertinent to State government.
- (4) A general library collection of a sufficient size and scope to reinforce and supplement the resources of local and regional libraries. All materials of the Department of Libraries shall be available for free circulation to all citizens, institutions, and organizations under regulations of the State Librarian except that the State Librarian may restrict rare or reference-type materials to one location. The Department shall arrange, classify, and catalog all materials in its custody and provide for their safekeeping and shall rebind books as needed. The Department shall provide service to other libraries in the State, schools, and individuals and may provide service by mail or book wagon or otherwise.
- (5) A service of advice and consultation to all libraries in the State, in order to assist them in realizing their potential. This service shall be provided at a regional level as well as at the State level. The Department may provide centralized cataloging and other related technical services to libraries in the State to the extent feasible.
- (6) All libraries in State correctional institutions and all State institutions for the treatment of persons with a mental condition or psychiatric disability and persons with an intellectual disability.
- (7) Reading materials for persons who are blind and persons with a physical disability.

Vermont State Library Collections


- 18,000 physical books
 - 1,060 Library Science for VT librarians
 - 60 Professional Development for State employees
- 5,000 government documents
- 85 serial subscriptions

The State Library's collections focus on Vermont history, Vermont law, Vermont authors, Native Americans, Library Science, State Employee Professional Development, and a youth collection.

What is checked out? Primarily book discussion sets, with a much smaller number from the youth, Vermont, and library sciences collections.

- 12,000 Large Print books
 - Deposit collections to supplement collections at public libraries
- 280 Braille books
- 350 Accessible Youth items
- Talking Books on cartridges
- 111,000 books on demand through the BARD program

Libraries receive a discount on purchases from collections vendors like Baker & Taylor, Ingram, Midwest Tapes, Blackstone, Brodart.



Department of Libraries Legal Resources

- VTLIB holds a contract with Westlaw to allow departments to sign up for access to the Westlaw Database for their employees.
- Legal Resources for the public through Community Legal Information Center (CLIC)
 - Access to Vermont Law and Graduate School law library collections in Randolph, VT
 - Access to legal reference services
 - Legal self-help books available for interlibrary loan





Interlibrary Loan Usage

The statewide interlibrary loan service (CLOVER) is a web-based program that connects to any library catalog with a Z39.50 connection. This allows live searches of those catalogs so that only libraries with the item available are sent the request. Every library in the state has an account and can access the system to send requests to borrow items. Libraries are able to set lending policies for item formats, locations, and statuses.

Currently active on CLOVER are:

- 149 public libraries
- 64 school libraries
- 6 academic libraries
- 1 special library

Interlibrary Loan & Courier System

In 2015 the Vermont Department of Libraries (VTLIB) and the Green Mountain Library Consortium (GMLC) partnered on a pilot courier system for interlibrary loan among public libraries in Vermont. The pilot period began on January 25, 2016 and was a great success. VTLIB took over full administration of the Vermont Library Courier system on March 1, 2018. As the program expanded in subsequent years it has remained highly successful. In this program VTLIB contracts with Priority Express, a commercial courier service. When new libraries are enrolled, Priority Express works with them directly to decide upon the pickup location and schedule. Libraries can sign up for up to five stops each week. The more frequent the delivery, the faster the service to patrons.

The Interlibrary Loan Courier System is available for libraries to sign up. VTLIB manages this program including the contract warehousing, bins, and transport bags for this service. VTLIB provides an annual grant for public libraries participating which covers half the cost of one stop per week. For the most recent grant period (October 1, 2022 – September 30, 2023) that was \$571.35 for each library that applied and met the criteria. In total VTLIB spent \$60,563.10 in courier grants for the latest round.

Currently on the courier system are:

- 124 public libraries
- 7 school libraries
- 3 academic libraries
- 1 special library

Interlibrary Loan: COVID19 Impact

In March 2020 the COVID-19 pandemic led to the six-week closure of the courier system, as well as to libraries pausing interlibrary loan and/or implementing quarantine procedures for their materials. Most libraries restarted courier services by October 2020, except for Haskell Library which waited until border regulation changes were implemented in April 2021.

In 2021 we were able to use IMLS ARPA funds to increase the amount of the courier grants for the period of October 1, 2021 – September 30, 2022. Libraries were offered grants that covered half the cost of one stop per week if they had one stop per week. Libraries with multiple stops per week were eligible for a grant to cover the cost of one full stop per week. This led to four libraries adding a second stop per week, three of whom continued with the second stop after the grant period ended. In total, the grants for this period cost \$74,074.26.



Resource Sharing: Databases

- Vermont Online Library Fifty databases from Gale Cengage that is available free for all Vermonters. The databases include more than 60,000 full text titles and 95,000 indexed titles. Resources are available for all age ranges from elementary to college to adult professionals. These databases all have a host of accessibility tools built in, making them truly accessible to every Vermonter.
- LearningExpress With resources covering everything from careers, job hunting, resumes and cover letters to high school homework support and citizenship test resources there is something for everyone in this database.
- Udemy A collection of over 14,000 video courses available to Vermonters through their public libraries, covering a huge range of professional skills and hobbies.





Resource Sharing: The Palace Project

- 3,162 English eBooks
- 3,305 English eAudiobooks
- 1,156 Non-English materials
- 187 professional library resources for VT librarians
- 92 professional development resources for state employees



This collection of eBooks and eAudiobooks, for every age and taste, serves as a core collection at no cost to libraries or readers. Consisting of diverse authors and topics, Vermont award winners, and Vermont-related books. Non-English titles support libraries serving their migrant worker communities, existing refugees, and new Americans in the state.

The Palace Project App enables access to resources from many publishers and vendors. Libraries can add to these resources based on their local needs and funding, specifically for their patrons from multiple vendors.




Resource Sharing: Palace App Usage



The Palace Project platform launched in June 2022, when it began being built out, library-by-library. There are currently 70 public libraries within the platform, with an additional 59 slated for the next onboarding phase.



Resource Sharing: GMLC Consortium



The Green Mountain Library Consortium has provided a downloadable eBook and eAudiobook solution for Vermont public libraries for 15 years.

- 13,757 eBooks (not including over 20,000 Project Gutenberg public domain titles)
- 12,351 eAudiobooks
- 240,909 eBooks circulated in the last 12 months
- 388,732 eAudiobooks circulated in the last 12 months
- 156 Participating Libraries
- Library subscription costs based on number of registered patrons and circulation




Vermont Collection Data & Trends – Public Libraries



Library Boards work with library staff to develop collection development policies. Each public library locally controls its collection development policy and which titles are available to their community at the library.




VT Public Library Data – Physical Materials Holdings

(Median library numbers)






VT Public Library Data - Median by Library Size (2021)





COVID19 Impact: Circulation of Materials

- Digital resource circulation increased
- Physical resource circulation decreased
 - Library closings
 - Reduced or no in-person browsing
 - Curb-side or front door service
 - Appointment-only or limited hours
 - Quarantining materials
 - Shipping delays
 - ILL continued, but courier system shut down for 6 weeks





COVID19 Impact: Increased Funding for Collections

IMLS ARPA Grants to Public Libraries:

- \$1,505,532
- 166 Public libraries received funds for purchases
- Grant Round 2 public libraries were encouraged to expand their EDI Collections

IMLS ARPA Grants to Consortia:

• \$200,000 GMLC eContent collections

VTLIB IMLS ARPA Funds:

- State library collections:
 - \$252,239 Palace Project eContent (perpetual licensing model)
 - \$10,720 Physical
- \$84,000 State institution collections



National Trends: Format Preference

Ebook Usage

- Increased from 25% to 30%
- Popular amongst the 18-29 age range (42%).


Audiobook Usage

• Adult users with an annual income of less than \$30,000 have increased from 14% to 22%.

33% have read both print and digital books in the past year.

% of U.S. adults who say they have ____ in the previous 12 months







National Trends: Format Preference






Print books continue as the more popular format. 33% of US adults report reading print and eBooks in the last twelve months, and 9% report reading digital books only.

Despite the decrease in physical collection use, total library collections (physical & digital) use reached a record high of 2.98 billion in 2019, growing 15.96% since 2013.
