Public Performance Site License for K12 Schools to Exhibit Motion Pictures (October 1, 2019 – September 30, 2020)

General Information

The Vermont Department of Libraries has agreed to manage the contract with Movie Licensing USA/Swank Motion Pictures for public performance motion picture licensing so that we can offer discounted prices to Vermont public and approved independent K-12 schools for the 2019-20school year. The movie license offered allows Vermont schools to show films for non-educational purposes and still be in compliant with copyright law.

The 2019-2020 license will be valid from October 1, 2019-September 30, 2020. Licenses will be backdated so as soon as we receive your agreement, you will be covered.

"Community" libraries (combined school/public libraries located in a K12 school): Movie Licensing USA has informed us that "community" libraries whereby both school and public libraries are housed in the school building, require separate licenses: one for the public library and one for the school. Licensing for public libraries are handled in a separate contract



L. 94-553).

- Movie Licensing USA has exclusive rights to license these motion pictures to Vermont K-12 public and approved independent schools on behalf of major Hollywood Studios which can be found at: http://k12.movlic.com and in this list:
